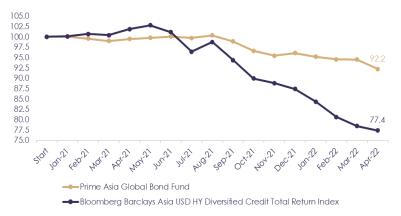
Investment Strategy

Prime Asia Global Bond Fund (the "Fund") aims to achieve a high level of income and moderate capital appreciation by investing in a portfolio of high-quality high yield bonds globally. The portfolio invests in all types of interest-bearing securities (fixed rate, floating rate, convertibles, preference shares, hybrid capital instruments) denominated in USD and non-USD currencies.

The Fund adopts a <u>global macro and cross-asset framework</u>, looking at not only the fixed income market, but also the stock market, macroeconomic factors, interest rates, forex, and more for our analysis. The Fund also adopts an <u>unconstrained approach to fixed income investing</u>, allowing us to opportunistically seek out attractive risk-adjusted returns globally, across the different markets and sectors.
